

# **VOLVO CAR MALAYSIA “VOLVO EXECUTIVE CAR SALES EVENT” (“EVENT”)**

## **Event Terms and Conditions (“Event Terms”)**

### **1. General**

This event is organized by Volvo Car Malaysia Sdn Bhd., Registration No. 199901007530 (482430-K), located at Lot 01-13A, 13A Floor, Menara Symphony, No. 5, Jalan Professor Khoo Kay Kim, Seksyen 13, 46200 Petaling Jaya, Selangor (“Volvo Car Malaysia”).

### **2. Event Period**

The event will be held on 19th – 20th October 2024 from 10:00 AM to 6:00 PM at Level 3A, Symphony Square - Menara Symphony, Petaling Jaya.

### **3. Eligibility**

- (1) The event is open to all residents in Malaysia aged 18 years or over.
- (2) Participants are required to register for the event either in advance or on-site upon arrival.
- (3) Test drives are only available to those who hold a valid driving license.

Volvo Car Malaysia reserves the right to verify eligibility requirements are met and may require such information as it considers reasonably necessary for this purpose.

### **4. Vehicle Purchases**

- (1) All vehicles available at the event are certified under the Volvo Selekt approved used car program.
- (2) Purchase agreements are to be finalized at the event, subject to a non-refundable deposit. The final payment and any additional charges such as taxes and registration fees must be settled according to the agreed terms.

## **5. Financing and Payment**

- (1) Financing options are available through Volvo Car Malaysia's partnered financial institutions (Maybank, Public Bank, RHB).
- (2) Terms and conditions for financing are subject to the policies of the respective banks.

## **6. Test Drives**

- (1) Test drives will be offered during the event, subject to availability.
- (2) Participants who register for a test drive at the event and comply with all safety rules and guidelines provided by Volvo Car Malaysia staff and authorized dealerships.
- (3) Volvo Car Malaysia reserves the right to refuse or revoke test drive privileges at any time for any reason.

## **7. Cancellation and Changes**

Volvo Car Malaysia reserves the right, at its sole discretion, to amend, cancel, or postpone the event due to unforeseen circumstances, safety concerns, or any other reason deemed necessary. Registered participants will be informed of any significant changes to the event without undue delay.

## **8. Data Protection**

Volvo Car Malaysia will only use participants information to administer the Event. Volvo Car Malaysia will observe and comply with the provisions of the Personal Data Protection Act 2010 and/or any regulations, rules, standards, or directions (including all the amendments made to the same from time to time) passed thereunder when it is processing the participants personal data.

## **9. Limitation of Liability**

- (1) Volvo Car Malaysia expressly disclaims any liability for personal injury (including death) or property damage that may arise during the event. While standard insurance coverage will be provided for all participants engaged in activities involving Volvo

vehicles, it is strongly recommended that participants maintain their own personal insurance coverage.

(2) Except for any liability that cannot by law be excluded, Volvo Car Malaysia (including its respective officers, employees, and agents) excludes all liability (including negligence), for any personal injury (including death); or any loss or damage (including loss of opportunity); whether direct, indirect, special, or consequential, arising in any way out of the Event.

(3) Except for any liability that cannot by law be excluded, Volvo Car Malaysia (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence) for any personal injury (including death) or any loss or damage (including loss of opportunity) whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Volvo Car Malaysia's control) (b) any theft, unauthorised access or third party interference.

## **10. Miscellaneous**

(1) Volvo Car Malaysia reserves the right to disqualify any participants from this Event at any time if it has reason to believe that these Event Terms are not being observed or will not be observed, or the information provided by the participant at the time of registration is not true or accurate.

(2) If any provision of these Event Terms is held invalid by any law, rule, order or regulation of any government, or by the final determination of any court of a competent jurisdiction, such invalidity shall not affect the enforceability of any other provisions not held to be invalid.

(3) These Event Terms, and all issues arising out of it shall be governed in accordance with the laws of the laws of Malaysia and are subject to the exclusive jurisdiction of the courts of the said territory.
